10. PRESIDENT'S REPORT:

President Stephen von Sychowski reported on activities since the April 2022 meeting.

<u>Meetings</u>

Our goal is to host a hybrid meeting in July. This is expected to be a fairly light meeting and a good opportunity to test this technology and approach.

Political Action

Our endorsement process is still underway, with the remaining decisions to be made at our June regular meeting. Please try to ensure you can attend that meeting as it is important to have all affiliate voices heard on these important decisions.

On May 18th the Broadway Plan will be debated by Vancouver City Council. The plan goes live on May 11th and registration will then open for speakers. A motion to support the plan is on this month's agenda.

Unfortunately, Jeanette Ashe was not successful in the Vancouver Quilchena byelection. Kevin Falcon is now headed to the legislature and aims to rebrand the BC Liberals and steer them back into government. We cannot allow the BC Liberals to obscure the truth about their legacy in government, with Falcon was a leading part of. While their name may change, it is clear that we are still dealing with the same old Liberal Party which did so much harm to working people and families. We need to keep BC moving forward.

On that note, there is also good news this month on the provincial scene, with the tabling of the Anti-Racism Data Act by the BCNDP, which aims to collect data which will be used to identify gaps in programs and services, and allow government to better meet the needs of Indigenous, Black and racialized British Columbians. The act is the first of its kind in Canada to be co-developed with Indigenous Peoples. We also saw the expansion of the BC PharmaCare formulary to include additional medications, including some ulcerative colitis and Crohn's disease, severe hypoglycemia, migraines, the treatment of low white blood cell levels, multiple sclerosis, heart failure, and birth control.

Labour Education

Our course on election rules took place on May 5, having been previously postponed due to facilitator illness. It was well attended and very informative. We now have four more classes to complete before our summer break. On May 18 we will host our first in-person course since the beginning of the pandemic.

The Fall/Winter program is currently in development.

The Worker Education and Labour Learning Society has brought Justin Chen back on a second contract term this May and June to further develop its website by populating its various sections content and resources. I am acting as the contract manager for this short term.

We also heard from Tracy Ford, whose father passed away from mesothelioma and who founded the AREA fund to raise awareness of the dangers of asbestos.

The Anti-Racism Committee organized an excellent event on May 1st, bringing together many labour activists for important discussions around building anti-racist workplaces and unions. We also shared CLC and affiliate content to mark the day. I look forward to returning to our traditional in-person march and rally next year and feel it could also exist in tandem with another anti-racism event if the committee wishes to do so.

12. CANADIAN LABOUR CONGRESS REPORT:

Ron Stipp reported on the Canadian Labour Congress since the April 2022 meeting.

Federally, we are still working very diligently on the supply and confidence agreement between the two parties in government and ensuring that the deal is adhered to. We are not having a lot of problems with it, but the devil is in the details, and we continue to be very vigilant that the Liberals adhere to the agreement. If need be, we will ask people to apply pressure to Liberal MP's in our region. From the few rumblings that we hear on a few bills, we have managed to shut that down.

One is the budget implementation bill, which is going through the House of Commons right now. There is a lot of work being done on the EI part of this. There will be improvements to the EI program, but we are having problems pushing through some of the things we'd like to see. The NDP is working extremely hard on our behalf on this, and we hope by the end of this we will see these improvements on the EI program. The rest of the implementation stuff is going well. There will be a lot of bills coming up in the fall around dental care, Pharmacare and things like that.

There is a private members bill on pension protection, Bill C-228. It's a Conservative bill, which is being amended by the NDP and the Bloc. It's pension protection that we've been requesting for years around bankruptcy of companies that pensions go up to the top. It's interesting that it's a Conservative, private member's bill. It's being improved with the help of the Conservative's on this as well. There is also a second bill by the NDP, by MP Daniel Blaikie out of Manitoba. There will be a combination of these two bills in the next while. We are on the second reading and are hoping for a third so we can propose some good amendments to the bill. We are hoping we get this bill passed this session before the end of the year.

On the provincial scene, very good news on card check. It is in third reading in the provincial legislature. We suspect that the third reading will go well, and this will be in place in early June. We have every indication that it will receive royal assent in June and then will be implemented and we will finally have card check in BC and for the labour movement is phenomenally important and very good news.

On the Municipal front, we are doing candidate workshops now. We've completed two and have five to go in Kelowna, Victoria, Nanaimo, Lower Mainland, and Prince George. We have mainly new candidates participating in these 6-hour workshops. Thanks again to Stephen and the Political Action Committee to get people to participate in them and they are going very well.

Endorsements are not only going on in Vancouver, but across the province. We have set a deadline for the end of June when endorsements will be completed province wide. This will be so we can get our poll and e-cards and get out the vote effort over the number of months, especially in September. We have received the postal code sort, and this will go to all of your affiliates to sort your membership into labour councils so your members will receive their pole cards to let them know who is running their community.

Finally, the CLC convention dates are set for May 8-12, 2023. This will be an in-person convention in Montreal.

Subject: Broadway Plan

BECAUSE the Broadway Plan will be before Vancouver City Council on May 18: and

BECAUSE the Broadway Plan represents an opportunity to improve affordability and sustainability while building thousands of new units of housing in walkable, transit-oriented neighbourhoods with nearby shops, services, and SkyTrain; and

BECAUSE the Broadway Plan will create a "jobs corridor" which allows working people and families to live near where they work while also having access through public transit to the broader region, and to UBC; and

BECAUSE at the same time, redevelopment can mean the displacement of existing tenants which can harm affordability and increase housing insecurity; and

BECAUSE the Broadway Plan attempts to alleviate these concerns through existing tenant protections, and Mayor Kennedy Stewart is asking for City Council's support to further strengthen protections by ensuring that those paying modest rents have the right to return to their new rental building at the same rent as before or lower,

THE VANCOUVER AND DISTRICT LABOUR COUNCIL WILL support and encourage the approval of the Broadway Plan by Vancouver City Council; and

THE VANCOUVER AND DISTRICT LABOUR COUNCIL WILL FURTHER encourage the adoption of the strongest renter protections in Canada through the Mayor's proposal to ensure that existing tenants are not displaced from their neighbourhoods as a result of redevelopment.

Sam Wiese has accepted a one-year term as President. Returning to the Executive Board are Gord Savard stepping into the position of 1st Vice President and Danny Bradford as our steadfast Treasurer. New to the Board are Gwenne Farrell as 2nd Vice President and Marion Pollack as Secretary.

The Board meeting and Spring edition of the Advocate are on our website, <www.bcforum.ca>. We are in the process of putting together our Summer edition of the Advocate in which, with our greatest thanks, we hear from Stephen Von Sychowski on issues of intergenerational activism.

May saw our 1st outreach in over 3 years with a BC FORUM table at the CUPE BC Convention. If affiliates are having in-person conferences, please let BC FORUM know whether it would be appropriate to set up an information table, even if for only a few hours. Or, if they would be willing to distribute BC FORUM pamphlets to participants. If virtual conferences, we have willing speakers on the relevance of BC FORUM if they have a spare 5 minutes on their agenda.

BC FORUM continues to educate and encourage its members to take action on various important issues such as the federal government putting off changes to the Patented Medicine Prices Review Board (PMPRB) regulations 4 times in the past, thus effectively caving in to the pharmaceutical industry and its allies when it comes to making prescriptions for Canadians more affordable.

Yesterday, BC FORUM sent an email to its members encouraging them to send an email to their MPs and the Senators from their province and key government ministers in support of

Bill C-228: An Act to Amend the Bankruptcy & Insolvency Act, the Creditors Arrangement Act and the Pension Benefits Standards Act, 1985. This new Act, sponsored by MP Marilyn Gladu, will be debated and voted on in June. If passed, it would go a long way in protecting pensions.

BC FORUM is also being active in getting out the word about the importance of keeping up with COVID booster shots, particularly for seniors. These are only 3 of the many issues that BC FORUM is currently addressing.
